The APA Board of Directors has been busy updating policies and procedures to maintain best practices.

The new APA Recording and AI Assistant Usage Policy adopted in July does not allow recording or artificial intelligence (AI) software "bot" attendance at public or private meetings and events except for limited

conditions in which a single official recording may be made.

The Whistle Blowing Policy adopted in November affirms APA's commitment to handling all matters legally and with integrity and ensuring that anyone who reports ethical misconduct is protected from retaliation.
